Welcome and Introductions:

- Michelle Morgan Loughman from the Electrical Contractors Association- the first trade association to become a Partner of the School, was introduced to the group.
- Sarah Jane Waith from Transport for Wales was introduced to the group as a new Partner of the School

The group was shown the budget recommendations for the School. Wales has £35,960 budget to spend for the next financial year. The group was shown an example of a business plan that could be used for Wales:

Wellbeing of Future Generations Act event:

At the previous leadership group meeting the group discussed that they would like to run an event focused on the Wellbeing of Future Generations Act which would involve contractors leading the event to inform clients on the delivery of the act and sharing best practice. The group agreed that this event should be open to all tier 1 contractors within the Wales leadership group.

- The group agreed that they would like this event would be a half day event which would take place at the end of April
- Sarah-Jane Waith from TFW to send through a list of Social Enterprises that have room availability for events
- The group agreed that colleges and universities that use the act should be invited to the event

Event update:

This year Wales has delivered 10 workshops with two more in the pipeline before the end of March. Wales has also delivered 3 supplier days, one of them being the SEWSCAP 3 Framework supplier day which is the biggest supplier day the School has ran to date. The homes market of the School is looking to potentially run a breakfast briefing in Cardiff at the end of March. Wales alone has had 568 learners at training, overachieving the target of 400 learners at training.


Wider School Update:
