
Dear Colleague,

Step 2: Enter your email address as your username and your personal password. If you have forgotten your password, please select the “forgotten password” link and you will be sent an email to reset it securely.




If you do not have an account with the School, you will need to select the “sign up” option and follow the instructions on screen.

Step 3: On logging in, you will be directed to the landing page for each learning pathway. Click the blue button to “ENROL”.






Step 5: To access the pathway you have just enrolled in and click **“ENROLLED PATHWAYS”** (the top blue button, highlighted in red above).

Logging in to the Supply Chain School & Accessing the Ipieca Labour Rights Training Learning Pathway




Step 6: Click either “VIEW PATHWAY” or anywhere within the pathway description and the list of resources which need to be completed will drop down.

NB: You may find it easier to open each resource in a new tab in order to complete it. To do this simply right click on the hyperlink and select “open in new tab”. This will ensure that the learning pathway remains open in the original tab for you to easily access.




Step 8: Once a resource has been completed, the grey box beside each will automatically tick itself
