had increased substantially with numbers of learners increasing by 132% relative to corresponding period last year. 236 training activities had been delivered from April 2020 – end Jan 2021. A slight decrease in number of organisations was seen – but two months of the current financial year remained so likelihood is that this figure will also be above corresponding level for previous year.

Scotland Update

The Scottish Region has 300 active School Members, from 1120 corporate accounts. The number of active members had increased by 33 since November 2020.

Target by end of FY 2020/2021 was 500. For the Scottish Market (encompassing the entire supply chain in Scotland so also including relevant companies doing business in Scotland, but located in England/Wales/NI) has 2,655 accounts and 690 active members (621 in November 2020).

Targeted marketing messages to encourage more active participation in the School across the Scottish based supply chain was having a positive impact.

Waste - Plastic Packaging Homes Data Trial

Nick Ribbon (ZWS) updated the meeting on progress in terms of quality of data being reported, and likely future activities which this pilot study will provoke. Full results and a report on the pilot project will be available at the next meeting scheduled for May. The Plastic Packaging tax is being introduced on 1 April 2022, so industry has an urgent need to address the quantity and type of plastic packaging it uses. The aim of the pilot is to demonstrate how much plastic is currently being used, and how much can be reduced and eliminated from the supply chain / waste stream of the construction industry, through new ways of working and different packaging materials / methods being used.

3. Learning Pathways

Learning Pathways have seen good levels of engagement since they were introduced by the School as a method to increase and deepen learning on a particular issue, Partner's staff and/or supply chain, or marketplace. Pathways can link together different resources into a connected experience, and individuals can demonstrate completion by gaining a badge.

Partners are using Pathways to direct suppliers to specific topics in line with their sustainability priorities. For example SGN and SPEN are both using this method to engage suppliers and subcontractors in particular learning issues and School resources.

- Pathways / resources most suitable for Scottish market and aligned to 2021/2022 business plan


4. Scotland Business Plan 2021/2022

The 2021/2022 business plan has been developed from discussions during the November 2020 meeting, and subsequent discussions with Leadership Group partners in December 20 and January 21.

The accompanying slides provide detail on the 5 key priorities for Scotland:

- i. Build carbon literacy and measure impact on carbon reduction
- ii. Standardise engagement and activation of priority suppliers
- iii. Increase access and use of online learning
- iv. Increase membership across Scotland
- v. Develop new learning content and pathways for Scottish Market

Core theme would be learning and measuring the School's impact on Carbon. The 2020 annual survey for Scottish members (results due in March 21) would show a useful baseline for carbon related impact Other learning priorities (eg MMC and Circular Economy) would support this core theme, as follows:

The School would create new E-Learning Modules relevant to the Scottish Market, including Circular Economy and Carbon. This activity would provide potential for new Learning Pathways, for example on Carbon, which could be promoted and used more widely across Scotland to increase knowledge and awareness through the supply chain.

Discussions were held on the Business Plan itself, and the opportunity to connect School activity to the UN Climate Change Conference COP26, being held 1-12 November in Glasgow.

Suggested additions or complementary activities for the Business Plan were:

Increase awareness and understanding and use of the Passivhaus standard to reduce carbon emissions over a building's lifetime

Consider issues such as "Designing out Carbon" and "Procuring out Carbon" to influence decision making "upstream" in construction and infrastructure projects.

Include if possible awareness / protection of Natural Capital

Emphasise importance of obtaining and managing accurate Carbon Data, and how the Carbon Tool can assist with measuring supply chain carbon

In terms of planning activity for COP26, the School was requested to connect with SP Energy Networks, SGN, Zero Waste Scotland, and CSIC primarily to take advantage of any synergy and provide best value to industry. Any application or eventual activity being run by the School – either as part of COP26 or as a "fringe" activity to coincide with the Summit, would be communicated to the Group for onward dissemination to supply chain in Scotland.
