General School Update:

Mark Turner, Sector Lead for Facilities Management informed the group that the School now has 173 Partners. Please see the image below for the Partners have joined the School recently:



The group was also shown the results from the impact survey along with new resources that have been developed for FIR, Digital, Procurement, Wellbeing, Modern Slavery & Plant. The group was also remined of the FM Conference that took place last year and was asked to provide feedback. Please refer to the pre-read for further information.

Building Safety Act Update:

David Emery, Consultant was invited to the meeting to provide the group with an update on the Building Safety Bill. On the 28^{th of} April it was announced that the Bill has become a law. The Bill was created to make provision about the safety of people in or about buildings and the standard of buildings, to amend the Architects Act 1997, and to amend provision about complaints made to a housing ombudsman. According to reports only a quarter of construction firms are prepared for the Building Safety Bill. There are also significant implications for FM service providers who have obligations to maintain safe buildings for clients and service users.

Update on current market conditions

The group had a discussion on current challenges within the FM sector. Bouygues expressed that there are challenges around their de-carbonisation strategy as most of their direction emissions come from fleet. This met with agreement from other partners. It was expressed that there are difficulties sourcing electric vehicles due to cost and lead times. There were also discussions regarding travel spend being a challenge with employees completing site visits etc.

It was discussed if there could be a Lunch 'n' Learn on the current challenges within FM with a view to examining ways in which solutions might be found to some of the seemingly intractable problems created by current market and geo-political conditions.

Reporting API 1.0

The group was informed of an application programming interface which is a software that allows two systems to communicate with each other. The API will be launching in the School in due course and will allow Partners to pull the data they want directly from the database into their own system. Data is being made available for priority suppliers and internal colleagues.

The School is asking all Partners who host the School's e-learning modules on their own in house LMS systems to feed resource views back into the School database. This will negate the need for Partners to provide this information to the School on a quarterly basis.

So, what will Partners be giving the School access to with the Reverse API?

- How many times a resource has been completed on your platform
- Resources accessed v. resources completed3 How can Partners get started and implement the API?
- The School will shortly circulate API documentation to all Partners this will include full JSOM files and endpoint confirmation.
- Partners will need internal capability to plug the API into their own systems. Please note however The School is not resourced to provide tech support in this instance.
- Partners can choose which endpoints they wish to engage with; you do not need to take them all!
- The reporting API is included within your Partner benefits; there is no additional cost to take it up
- Partners who host the School's e-learning modules on their LMS systems to feed resource views back into the School database.
