## 2. Partner Update

Information and news was shared from prime contractors, major suppliers, client partners and industry stakeholders in Scotland. Main actions were captured and are included in these notes. Selected highlights included:

## **Morgan Sindall**

Company has a Responsible Business Plan and at its recent Spring Briefing has made 5 commitments to sustainability. Delivering a session on the Net Zero Public Sector Building Standard. Recently was awarded Champion status under the Carbon Reduction Code

## Scottish Water

Have introduced KPIs and KPCs around carbon reduction for the value chain. Encouraging more development on new technologies and innovation such as Hydraulic Road Binder "Smart" approach by Mackenzie Construction.

## **SP Energy Networks**

Part of the Scottish Business Climate Collaboration (SBCC) – a business support and information portal aimed at SMEs, which will be presented at the next meeting. Have run "Introduction to Sustainability" sessions and grown the number of suppliers who are members of the School.

## **Robertson**

Engaged in Passivhaus projects and developing their expertise at delivering assets to this high standard. Have invested in sustainability by growing their staff numbers who support the group, and appointing Graeme Hannah as Director of Sustainability and Social Impact.

## **Marshalls**

Carbon Emissions fell 50% from 2008-2020. Production facilities are investing in renewable energy with 8,000 tonnes of CO2 being saved so far from use of green energy. Continuing to reduce use of plastic wrapping on their products and have a new pressing technology to further improve performance.

## <u>Multiplex</u>

Multiplex has been appointed as the main contractor and Programme Delivery Partner on the University of Glasgow's campus development programme. The project will be delivered under an NEC3 Option C contract, with Phase One A including the construction of a new Learning and Teaching Hub on University Avenue and the development of the former Western Infirmary site. The second phase will include a new Centre for Chronic Diseases and the creation of an Innovation Quarter.

Have now launched both Sustainability and Social Equity Strategies. Working as part of Concrete Zero and Steel Zero initiatives to send message to key industry suppliers that demand for new innovation in materials continues to grow.

## Zero Waste Scotland

Developing and delivering training on the Net Zero Public Sector Building Standard, with CIRIA. Have recently commissioned a report on Embodied Carbon Emissions in the construction setor which should be shared with the group – this can lead into a discussion and action planning on Scope 3 carbon at the next meeting

## **Balfour Beatty**

Focus on Circular Economy with dedicated supply chain workshops and training on this issue. Have fed information to Scottish Government planning/thinking on CE, via stakeholder session with Envirolink Scotland. Will be keen to respond to CE Consultation with other partners.
