2. Partner Update

Information and news was shared from prime contractors, major suppliers, client partners and industry stakeholders in Scotland. Main actions were captured and are included in these notes. Selected highlights included:

Multiplex

Multiplex becoming active in the retrofit market – to be sent details of what the School is doing to support the retrofit agenda.

Robertson

SCSS Membership is mandated as a pre-qualification requirement. The company have signed a Sustainable Growth Agreement with SEPA to drive performance beyond compliance for themselves

SCSS will support the SGA by hosting content and learning materials using its Learning Pathway functionality, to enable suppliers to work through training and demonstrate their shared commitment with Robertson. Specific resources to be presented at the Robertson page to make it easy for suppliers to engage with the School and support Robertson's 2030 Responsible Business deliverables.

Kier

54% of suppliers are now members of the School which is a good increase on baseline. This can be increased still further.

Scottish Water

EV salary sacrifice scheme is in operation for staff, and Ian gave an overview on how Scottish water is now reporting on carbon

Balfour Beatty

Balfour Beatty are working with their supply chain on plastic waste, EVs and the Circular Economy. They are also providing Climate Emergency training to their suppliers. Actions from several workshops the company have supported are being included in the next report on Circular Economy, particularly with regard to the Scottish Government's CE Route Map

SSE

Together with other organisations, SSE have produced a "Powering Net Zero" pack for SMEs – which could be similar to the information and learning support being developed through the SBCC. Nolan would send the details through to inform Partners. This is a collective drive to make real change in the 5 commitment areas, and not owned or to be seen as 'SSE's initiative'. Driving Social Value is a big issue which SSE is focussed on.

SGN

Mapping SDGs to their approach to sustainability and they are now employing a Sustainable Procurement Manager for the first time. They have a Net Gain strategy regarding Biodiversity and are working a lot with Energy Futures on the Eastern coast / Aberdeen. They are doing a lot of research on mitigation work to reduce flood risk to their assets.

RΔM

Focussing their strategy on 4 key areas of Social Value, Carbon, Circular Economy and Biodiversity. They have a target of being Net Zero organisation by 2026, and are doing more work with the Passivhaus Standard. BAM are also engaged in Embodied Carbon Assessments with their partners and suppliers.

VGC

Involved in a lot of Offsite / MMC work within the HS2 Project – with work on modular buildings. They are also providing renewable energy mobile generators (no diesel) to many sites alongside their customers and partners.

SPEN

Decarbonisation of electricity used for transport and heat is a big item for SPEN. They have an environmental action plan and are focussed on reducing Scope 3 emissions (as well as 1 and 2).




