## Case Study: Jacksons Fencing

#### Challenges:



Jacksons Fencing has identified sustainability as a major challenge, particularly in regard to auditing and documenting their actions.

Despite implementing various sustainable measures such as a 25year guarantee, recycling office waste and offcut timber, sourcing

timber from responsible sources, using solar panels to power their workshops, and repurposing packaging shavings as bedding, Jacksons has struggled with calculating emissions and determining their carbon footprint.

The company places a strong emphasis on the environmental pillar of sustainability but has not focused as much on the economic and social pillars. They are currently working on addressing this gap in their sustainability efforts.

#### Impact:

A better understanding of carbon emissions: Jacksons Fencing has engaged with the Supply Chain Sustainability School and generated a learning plan to better understand sustainability issues, including modern slavery. This learning plan has provided the company with a



deeper understanding of carbon emissions and the standards required to conduct life cycle assessments for their products.

**Establishing timelines:** The company has found the School's assessments motivating, and appreciates the opportunity to receive a certificate at the end of each module. They have also found the accompanying action plans helpful in establishing a clear timeline for gaining certifications. These efforts have benefited the company by allowing them to display its certification and focus on sustainability issues within the business.

**Diverse learning materials:** The e-learning modules provided by the School are diverse in subject matter and have given Jacksons Fencing a starting point for improving its sustainability as a company.
