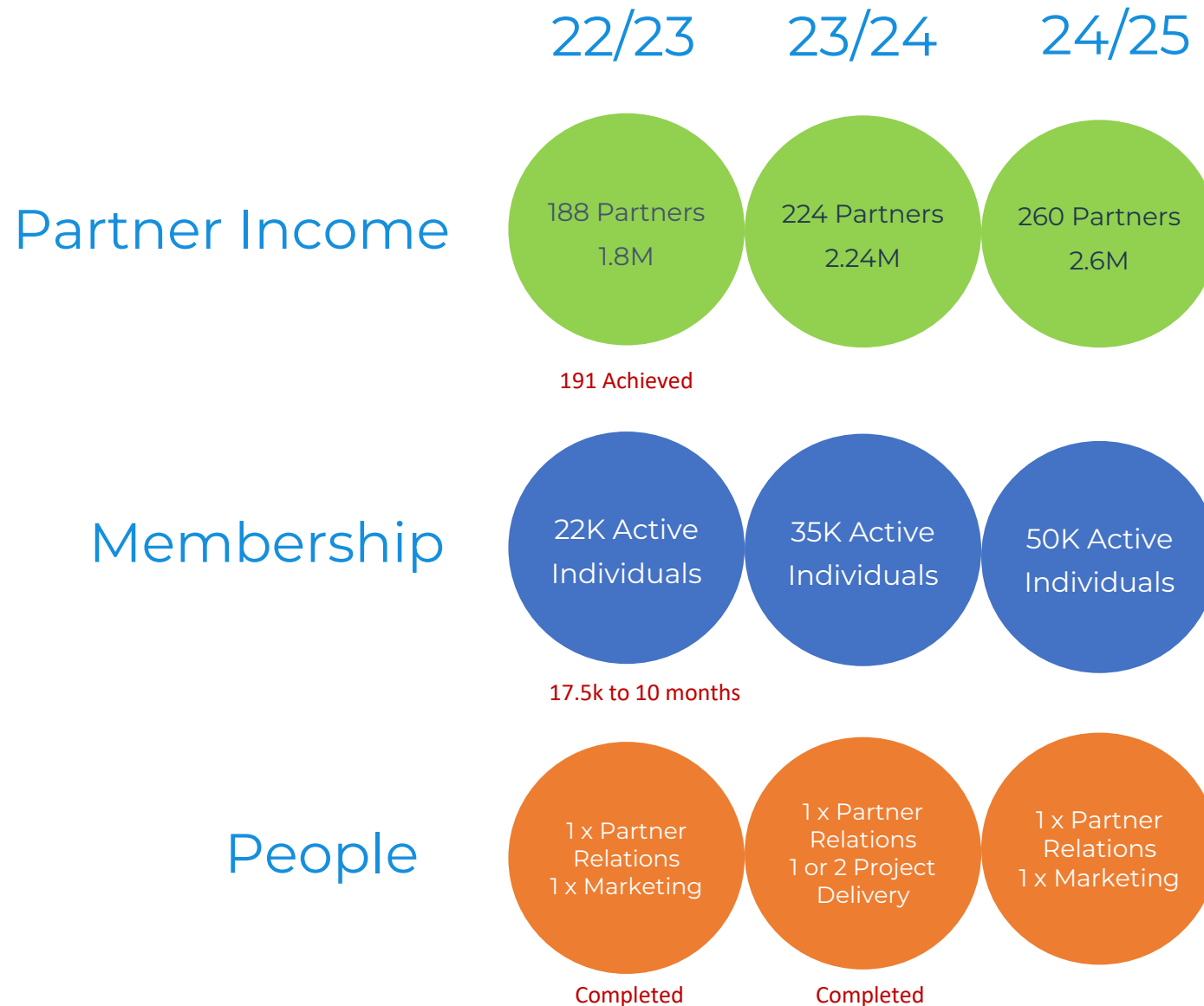


Our Goal:

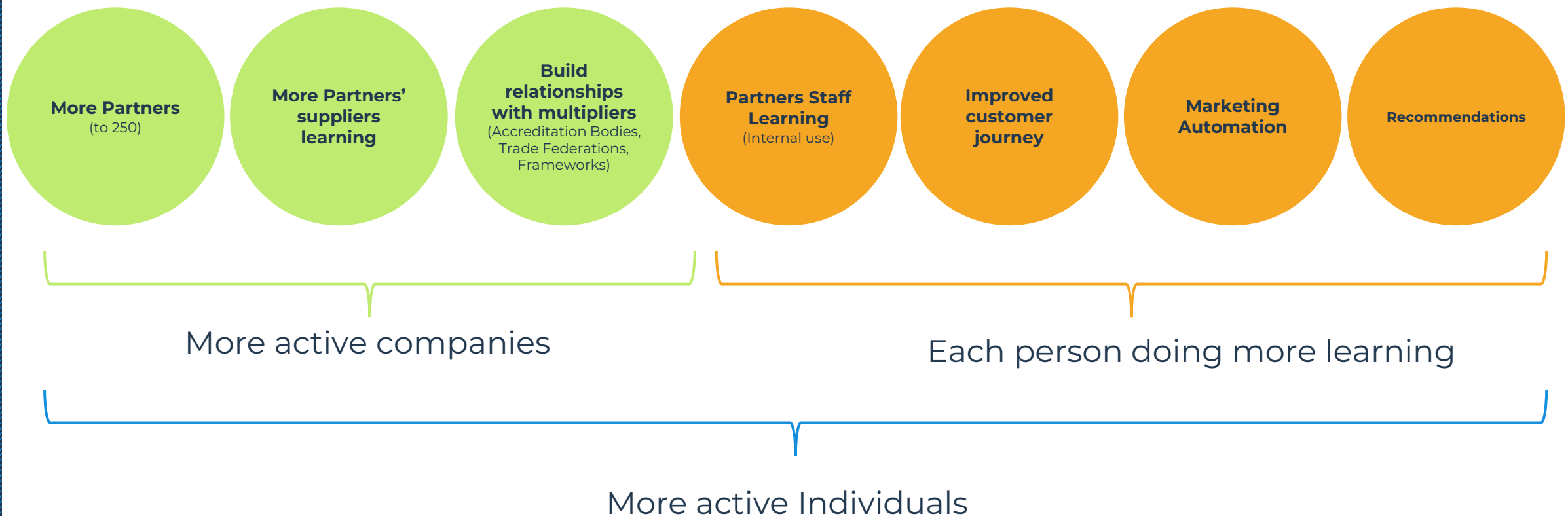
