#### 5 Business Planning 2025/2026

The results from the last Leadership Group session were collected and analysed to identify three planned activities which will be the focus of the Group for FY2025/2026. These included:

- 1. Setting up a Working Group to develop consistent telematics metrics and KPIs. Getting consistent telematics data to use for efficiency drivers was highlighted as a key challenge. Setting up a Working Group is intended to address this.
- Publishing a report that explores alternative fuels and their feasibility (in place of diesel). This would include a review of lithium ion batteries and other power forms not already explored in the already published HVO and Solar Panel Guidance documents. CLC have set a target for 78% diesel free on all UK sites by 2035, meaning a move towards other fuel sources is required. This report would support this transition.
- 3. **Development of a Sustainability Short on fuel efficiency** aimed at site operatives and managers.

More content is needed aimed at people working on site to ensure that the message on fuel efficiency is clearly communicated and understood. This short would be aimed at an on-site audience and so address this.
