

Focus 2025-6

To <u>educate and upskill more people</u> in the Scotland sector about sustainability and build maturity in key priority areas across partner supply chains

Progressing the Scotland Training Programme with Training Sessions / Virtual Conferences to build knowledge in key issues for the Scotland market value chain:

Collaborate to reduce carbon and highlight energy issues

- Run virtual conference for the supply chain related to energy/carbon & retrofit in Scotland
- Engage in the Climate Action Group to shape content Partners to have representatives on the group and task groups. Key priorities: Embodied and Whole Life Carbon, EPD's, HVO/alternative fuels, Future Homes Standard

Collaborate on waste reduction and resource efficiency

- Deliver training on designing out waste and circularity with a focus on Zero Waste Scotland's material hubs via a Virtual Conference on Resource Efficient Design & Innovation involving Zero Wate Scotland on the Munich project (likely in November 25) engage relevant individuals in this training
- Engage in the waste and resource efficiency group to shape content Partners to have representatives on the group

Collaborate on social sustainability, community wealth building and FIR (Fairness Inclusion and Respect programme)

- Deliver training day for partners to collaborate on social sustainability enabling partners to pool their thinking and knowledge in this area
- Deliver training on community wealth building and FIR involving Scotland partners and stakeholders such as Scottish Futures Trust

Collaborate on biodiversity nature positive, adaptation and resilience

- Deliver training on biodiversity and nature involving NatureScot and others eg peatland protection, new code, adaptation and resilience, designing in natural materials.
- Engage in the nature group to shape content Partners to have representatives on the group

Task Groups will be established to develop outputs/outcomes on the following key areas:

Future Workforce

1. Colleges recruitment of new partners - We will recruit colleges in Scotland to become School partners to ensure the future workforce has access to the School's sustainability agenda. This will be done through collaboration between SLG partners and the School's Future Workforce programme to communicate the combined strength of the School's Scottish partners. Our target is to involve 5 colleges this year.

2. Future Skills Video - showcasing Future Skills and decarbonisation with a partner in Scotland.

Existing Workforce

- 1. Sustainable Construction Sites E Learning and Launch Webinar (1st October 2025) The School to edit the videos from the e-learning module on Sustainable Construction Sites which will feature Scottish Water sites. The leadership group will work together to ensure maximum exposure and use of this resource across Scotland. Target = 100 Scottish companies to complete this new resource.
- 2. Produce a separate short video resource to share best practise more effectively across Scotland on Sustainable Site set up and a learning pathway bespoke to Scotland.
- 3. Produce a Circular Economy Sustainability Short involving Zero Wate Scotland's expertise.

Priority 4 – Driving engagement and impact in the Scotland sector

- **Partners priority supplier lists** and set targets to their supply chains to engage in the School's learning contact Jenny in the Partner team if you need help eg creating sub business units etc.
- **Developing Scotland specific School Learning Pathways** and sharing other relevant pathways with suppliers eg Sustainable Site Set- Ups on key priority areas. Loraine will incorporate these into a priority supplier email to share with suppliers.
- <u>Partners assigning learning</u> (via the School's LMS / Learning Pathways or their own) to their workforce and to upload colleagues onto your company dashboard to maximise internal training consider HR including in appraisals.
- <u>Share Training & Learning links</u> as above with colleagues / HR and supply chain with an emphasis on the training being quality, free and CPD accredited. Loraine will circulate regularly.
- <u>Partners are encouraged to make introductions</u> to the School via Loraine as Scotland Market Manager key stakeholders eg clients, public sector, networks in the built environment
- Key Scotland Resources send Loraine any key Scotland resources relevant to the priority areas which you would like us to provide on the School
- Invite the School to your Supplier Days

Collaborate to drive engagement in the Scotland Supply Chain under the combined voice of the SLG within the built environment sector.

- Assist the School by continuing with introductions with multipliers and industry trade bodies, such as CITB Scotland, Constructionline, Transport Scotland, Scotrail, LA sustainable procurement networks, clients and other stakeholders.
