AGREED WORKSTREAMS (1ST APRIL 25 - 31 MARCH 26)

- Develop modern slavery due diligence capability assessment, aligned with BS 25700, mirroring the format of the recently launched sustainability capability assessment
- Run a virtual launch event of the above during anti-slavery week and plan to run a face to face conference in April 2026 (from next year's budget)

Drive impact and showcase good practice

- Partners / the School to continue to drive impact by **promoting the School's existing and new resources** to their colleagues and supply chain, for example the updated School Procurement Guidance on combatting slavery and labour exploitation and the updated supply chain mapping protocol guidance (both launching in April / May 2025), the operational toolkit, learning pathways, updated e-learning modules etc
- Deliver **4 webinars** on topics to be agreed high priority topics submitted by the group include: right to work, responding to modern slavery (grievance, escalation and remediation), good practice due diligence.

Collaborate to drive impact

- School to continue to be represented / engage with external forums / groups including YORhub Modern Slavery Group, CCLA Investment, Design for Freedom, BSA Modern Slavery Council, RSSB modern slavery group, Slave Free Alliance, Stronger Together Construction group, Unseen, upcoming APPG on Just Transition in the Built Environment
- Partners to continue to engage with Stop the Traffik and CCLA to develop the idea of creating a modern slavery intelligence network for built environment
