

Case Study: Green Valley Arborists Ltd (GVA)

Challenges:

GVA undertook a full carbon review of its operations and analysed its 2023–24 carbon footprint, providing a baseline to improve sustainability.

One of the biggest challenges identified was the significant impact of plant and vehicle emissions. To address this, GVA is undertaking a comparison exercise to assess the compatibility of hydrotreated vegetable oil (HVO) biofuel with existing assets. Early estimates suggest this could reduce carbon emissions by over 98%. A trial is scheduled to launch later in 2025.

Another key challenge has been upskilling staff and encouraging behavioural change. In response, training and communications have been issued to highlight the impact of vehicle idling and educate employees. GVA's company motto, 'Your Environment, Our Responsibility', is now embedded in all inductions and training programmes to promote a positive carbon culture from the outset.

Impact:
