#### **TRUST DEED**

This deed is made between:

- (1) National Highways Limited (company number 09346363) whose registered address is Bridge House, 1 Walnut Close, Guildford, Surrey GU1 4LZ (the *Client*) and

The *Contractor* hereby declares that upon opening the Project Bank Account it will hold the Project Bank Account and all amounts at any time standing to the credit of the Project Bank Account on trust for itself and the Named Suppliers in accordance with the terms of clause Y(UK)1 of the contract.

The parties to this deed agree that:

- no party may assign or transfer any of its rights and/or obligations under this
  deed to any person, provided that the *Client* may assign or transfer any of its
  rights and/or obligation to any successor of the *Client* under the contract,
- no beneficiary of the trust constituted by this deed may assign or transfer any
  of its interest under the trust constituted by this deed, provided that any
  person that becomes a Named Supplier after the date of this deed will be a
  beneficiary of the trust constituted by this deed in accordance with the terms
  of clause Y(UK)1 of the contract,
- a person who is not a party to this deed has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce or to enjoy the benefit of any term of this deed, except that, without prejudice to any other rights that a Named Supplier may have, a Named Supplier may enforce any provision of this deed against the *Contractor* as though named as a party to this deed and
- this deed is subject to the law of England and Wales.
