- Expand functionality for more mature companies
- Create a subgroup on developing a future vision for the carbon calculator
- Enable reporting by calendar or financial year
- Improve data validation processes
- Integrate with internal system (e.g. SECR, SDG's)
- Develop capability across the supply chain e.g. tier 2 and tier 3
- Dashboard should track improvement not just figures

 content)
 - 3. Procurement and contract KPIs for climate: Guidance material (new content)
